• The last Farmers Market date, August 23rd, has been cancelled. We are having a VBS celebration that night instead with a shorter Brendan Brooks concert and sundaes/root beer floats for the kids.

- Safe Church Training is still planned for Sunday, August 27<sup>th</sup> after worship that morning.
- Sunday School still needs to finalize the Gifts of Bethlehem date and a few other details about the year; the calendar should be final soon. Sunday School begins September 17th.
- I am working on the revisions to the confirmation calendar and creating an outline for the curriculum this year. Confirmation begins September 13th.
- Fruit of the Spirit Fun Nights; the last Wednesday of each month: I have not had any response from the youth about their availability to help with this, and I will no longer be available to do this. It is my recommendation that this is cancelled and maybe picked up by someone else in the future if desired.

# **Committee Reports**

#### **FINANCE**

Finance Meeting Held August 7, 2023

## Financial Update

1. Total income for July was \$22661, and expenses were \$21033 for a net profit of \$1628. YTD net is \$9930 vs last year's YTD was \$24941. Difference can be accounted for by significant costs for HVAC system. Two transfers needed to be made during the month to cover bills, some of it was related to the timing of bills and when money came in. Overall, finances are stable. There are a couple of bills that need to be paid but the money is in Designated savings

#### 1. Portico Enrollment

a. Briefly discussed Portico enrollment coming up in October and if there are any changes that need to be made. The only part of Portico that we can change is the health insurance. Pr Jaime is happy with her health insurance plan. A question was raised about how much costs were going up. This information isn't available currently. General consensus is that we will keep the current health plan.

# 2. Financial Update Sharing

a. Pr Jaime asked the question on how we share financial information with the congregation. There probably isn't much information given to them about the impact of their giving. There may be a perception that we only share financial information when it is bad. Conversation then explored how we could do this in a positive light. For example: "because of the congregation's continued giving we were able to do......" Whether we give money to community groups or support other projects. We discussed putting the information in Chimes & Bulletin or supporting an announcement during the service.

### 3. Memorial Bricks

a. Jaimie R asked a question about selling memorial bricks. She has been working with Del about selling the bricks again. The question she raised was about what we should sell the bricks for. Years ago, they were sold for \$50/each. While we still have 23 bricks that only need engraving, there was a question about the cost if we had to buy new bricks. The finance committee agreed price should be

raised to be closer inline to what the purchase of a new brick and engraving would be.

### **PROPERTY**

Watered newly planted trees each Monday and ran sprinkler in East ditch for grass along with several volunteers who do watering duty each week.

July 10, met with Wisconsin DNR to inspect well head and pressure tank, all passed.

July 22, Repaired electrical cord for trimmer and hauled some shrub trimmings to Portage dump area. August 1 installed new thermostat in kitchen refrigerator and monitored it and it is working properly.

August 5 Checked over lawnmower and picked up gas for it, watered trees.

August 8 & 9 Brian Conner painted all exterior doors and trimmed the main front hedge row by the Prayer Garden. Thanks Brian!

Note: Presently investigating doing an exterior door lock change given the number of keys not accounted for. Also looking into installing keypad for the East entrance door to cut down on the number of keys given to individuals. Will run through Council when we complete costs.

We are actively looking for new chairs for the Fellowship Hall, a question is what we should we do with existing old chairs? Allow members to take what they would want and then try and sell the rest. Did not feel right selling to members based on condition.
