Committee Reports

FINANCE

Meeting held November 6, 2023

- 1. For the month of October, BLC had \$31,707 of income and \$282,905 year to date. Comparing October 2023 to prior year, we have received \$31,125 more this year. This is primarily related to three items. We received \$17,205 more in Memorial offering, \$4,656 in Building-Mortgage offering, and \$22,936 in Mission Trip fundraising. General Offering is income is \$4,478 lower than prior year to date.
- 2. We continue to keep an eye on general offerings as they are trending lower than prior year. Building Mortgage Offering has offset this trend in 2023 with the above growth year to date.
- 3. Total Expenses for October 2023 are \$21,791, with no significant unplanned variances this month. Year to date, we have \$255,390 in expenses compared to \$226,281 in 2022 through October. This significant variance for 2023 year to date is related to replacing a rooftop unit, pew cushions, and chair replacements. Each of these was planned for in 2023.
- 4. Net income year to date is \$27,739. We do have approximately \$18k in outstanding invoices for youth mission trip deposits and old construction costs where the bill was finally turned in. This will reduce the year-to-date net income to about \$10k. Overall, we are in a position to replenish some of our reserves for future years.

2024 Budget

- 1. Jerry emailed Janice questions to ask committee chairs at the Church Activity Planning meeting and the committee chairs for any budget requests.
- 2. Building Account Fund raising
 - a. A discussion on replenishing the balance in the building fund. Since we have to probably purchase more air handlers, we will need more money in this account for this and other future maintenance.
 - b. We talked about ideas like- capital campaign, basic fundraising, incentive program etc. We also talked about where the responsibility for this lies.
 - c. We decided that it needs to be an active part of council meetings and other meetings, added to November council meeting agenda.

PROPERTY

Oct 20--Prepared Scag lawnmower for off-season, pressure washed, installed newly sharpened blades and put gas stabilizer in fuel tanks. Work accomplished with Butch Jahoda.

Oct 20--Installed new emergency light by Sacristy. Emergency light model was recalled because of possible fire hazard. Company sent new light at no cost.

Oct 24--Inspected all rooftop units before the heating season, all units checked out without any issues. Changed filters for the unit that supplies heating and cooling for the office area. Dennis Benson assisted.

Nov 4—Changed all thermostats clocks for DLS and verified heating schedules.

Was informed by Jerry (custodian) that he will be gone Nov 23 thru Dec 3rd. Will need one cleaning service by Kris.

Note: We can expect a 4% increase in utilities for the coming year.

STEWARDSHIP

Pastor Jaime, Brian Connor, Judy Traut, Jeff Melby, Kerry Melby and Lisa Cook met on October 26, 2023.

Pastor Jaime explained a formal pledge letter and card would not be sent this fall, and we would instead focus on practicing gratitude. It was decided to focus on four areas for the four Sundays of November; gratitude for people who have gone before us or people in our lives now, gratutide around the various ways we share meals / food, gratitude for ministries inside our church and gratitude for ministries outside our church. Thank you cards are being offered in the Narthex, with encouragement for members of the congregation to make a goal of sending out 2 thank yous during the month. A tree of gratitude was set up in the Narthex, as well, and each week will offer different colored cut-out leaves for people to add to the tree.

We will attempt to focus on the importance of giving your time and talents, not just financial giving. And we will look at ways to create conversation around financial giving and other avenues of stewardship as a year-round focus, instead of just bringing it up once a year during a pledge drive.

Further discussion centered around ideas or themes to focus on, going forward, in order to create a consistent message of gratitude and stewardship as part of our vision and mission at BLC. We talked about utilizing our projector and screen more often before, during and after worship for thank yous and updates about ministries, as well as creating a welcoming brochure / pamphlet to give out at events and a photo card for members of the congregation to mail out or share with people they encounter. Lots of excitement and enthusiasm was shared and there are plenty of ideas to pursue.
